Brief Overview of SAS

After serving as CFA's Assistant Executive Director since 2018, Scott Ross was promoted to the Executive Director position in 2022. Prior to that Scott served as CFA's Director of BRM and Farm Policy for six years, where he covered a wide variety of agricultural issues. Scott's policy work has given him a unique insight on how to develop and implement policy, while balancing a diversity of stakeholder interests. She started her career in the public service as Counsel for the Department of Justice. Prior moving to Agriculture, Sophie worked in National Security and Intelligence policy.
